SHORE LIMITED LIFETIME WARRANTY

WHAT IS COVERED:

Wilsonart LLC ("Wilsonart") warrants that the Shore Water-Proof Wall Panel Systems ("Shore") to be free of defects in material and workmanship during normal residential use for as long as the original consumer owns his/her home, provided the shower is installed by a Shore Certified Platinum Installer ("Warranty Period"). If Shore products are installed outside of the United States of America, Canada, or Mexico or used commercially, Wilsonart warrants that Shore will be free from defects in material for three (3) years from the date of sale ("Warranty Period"). To activate this limited warranty, the original consumer purchaser must register their Shore Wall Panel System within thirty (30) days of purchase.

WHAT IS EXCLUDED:

Wilsonart is not responsible for labor charges, installation, other incidental or consequential costs, or the cost of repair or replacement of any installation materials including but not limited to tile(s), marble etc. In no event shall the liability of Wilsonart exceed the purchase price of the Shore product. Damages due to improper handling, installation or maintenance are not considered manufacturing defects and are not covered by this warranty. This warranty is valid for the original, consumer purchaser only. Proof of purchase (original sales receipt) must be provided to Wilsonart with all warranty claims.

This warranty shall not apply to damage arising from any of the following:

- 1. Accidents, abuse or misuse;
- 2. Exposure to extreme temperature changes;
- 3. Exposure to harsh or corrosive chemicals and cleaners;
- 4. Excessive weight placed on or against wall panel;
- 5. Structural support or movement;

6. Improperly installed, used and/or maintained appliances, fixtures, or accessories;

8. Failure to use or maintain the product in accordance with Shore's published Care and Maintenance Guidelines (see information supplied to Shore's distributors and retailers)

WHAT SHORE WILL DO IF YOUR CLAIM IS COVERED BY THIS WARRANTY:

At no cost to the original consumer purchaser, Wilsonart will provide, at its option, repair or replacement of the warranted product. Neither transfer of residence ownership nor repair or replacement under this warranty shall extend the Warranty Period. Any repair or replacement under the warranty is limited to repair or replacement with Shore colors and styles of products available at the time of repair or replacement. If the original color or style is no longer available, Wilsonart has the right to substitute another Shore color or style of equal or greater value than the original product. Exact color matches may not be possible.
